- investing in training, education, research and innovation.



Administration on Aging

- Administers the Older Americans Act
 - Office of Supportive and Caregiver Services
 - Office of Nutrition and Health Promotion Programs
 - Office of Elder Justice and Adult Protective Services
 - Office of American Indian, Alaskan Native and Native Hawaiian Programs

OAA Title III

- **Supportive Services**: Adult Day Service, Transportation, Case Management, Legal Assistance, Chore, Homemaker, Personal Care, etc.
- Nutrition: Congregate Meals, Home-delivered Meals & more
- Disease Prevention and Health Promotion: Evidencebased programs
- Family Caregiver Support: Counseling, Education, Respite, Gap Filling or other Supplemental Services, etc.

OAA Title III, continued

- OAA does not have income requirements and prohibits means-testing.
- Targeting is required: older individuals with greatest economic need and older individuals with greatest social need, with particular attention to low-income minorities and individuals residing in rural areas.

OAA Title VI Tribal Organizations


- Tribal organizations (federally-recognized) must represent at least 50 Native American elders age 60 and over.
- Programs provide grants to Native American, Alaskan Native, and Native Hawaiian tribal organizations to promote the delivery of home & community supports including:
 - Nutrition services,
 - In-home care
 - Support for family and informal caregivers (older adult & grandparent)
 - These programs are responsive to the cultural diversity of Native American/Alaska Native communities and represent an important part of the Tribal organizations' comprehensive services.
- Washington has 26 Tribal Grantees



OAA Funds FY 2021


Older Americans Act Funds FY 2021




Consolidated Appropriations Act, 2021

Administration Priorities

- ACL is requesting budget authority of \$3,008,907,000
 - increase of \$750,792,000 over the FY 2021 Enacted level of \$2,258,115,000
 - To enhance supports for older adults and persons with disabilities
 - Expand Focus on Caregiving
 - Equity including Native American Nutrition and Supportive Services +\$35 million

Administration Goals

- COVID-19 has been THE priority for ACL and the Administration – ACL focus – vaccine access
- Caregiver Infrastructure Paid professionals and family caregivers
- Equity the President has directed all federal agencies to center equity in all our work

Administration Goals

- President's proposed \$400 billion Home & Community Based Services investment
- President and Congress have already taken some big steps in Medicaid HCBS:
 - American Rescue Plan with \$12.7 billion to HCBS
 - Money Follows the Person reauthorized for 3 years with expansion of eligibility
